

FUTURITY ENTRY RULES

1. Futurity class is open to any horse which is a foal of 2022. To enter in Futurity, horse must never have competed at any Barrel Race before November 15th of previous year(including ghost rides exhibitions (during a competition), open shows, registered shows, rodeos, playdays, showdeos, futurities, or closed exhibitions, with the exception of Futurity Showcase for exhibition only **NO** competition and open exhibitions must be available before or after show case exhibitions. Owners may enter more than one horse. Owner does not have to ride. Rider may be male or female.
2. Horse papers must list the name of the current horse owner at time of show, **transfers are not accepted**. All prize money or refunds will be paid to the horse owner on registration papers at time of show.
3. All barrel races will be held at Lazy E Arena 9600 Lazy E Drive Guthrie Oklahoma 73044. All entries due by **September 15th** Late fees apply.
4. Open to all breeds of registered horses. Original papers or Digital copy listing current owner must be presented at time of check-in.
5. Entries Paper work (Registration, Coggins & Health) will be inspected by State and/or BFA Official.
6. There will be 2 go-rounds, short-go and average in Futurity. Number TBD based on number of entries, Fastest times from the 2 go-rounds will go to the finals. Your slowest qualifying time will be dropped. Futurity qualifying rounds will be paid in 2D format, payoff will be progressive and will be 1 second split. The champions will be determined by your fastest go-round time combined with your Short Go time.
7. **No Refunds for ANY reason!** Payments must accompany nomination. **Substitutions - \$150 by September 20th, 2026**
8. **MUST BE SAME OWNER!-***There are **NO buy outs!!!! Lesses must be dated before September 1st, 2026**
9. Office charge of 20% of total entry fees per horse for advertisement and show production. * Entry Fee is less Stall, Office fees and Exhibition, see website for amounts. 80% of *entry fees and added money will be distributed. Owner AND rider of each entry must be a 2026 member of BFA. Amateur Riders must qualify for Amateur status as per AQHA rules AND must provide copy of a current AQHA, APHA, or APHC Amateur Card
10. If show is canceled before move in Entry fee **less** office fee, late fee will be returned, If show is shut down after move in date Fee **less** stall fee, office fee & late fee will be returned. Memberships are non refundable.

Total fee may be paid 1250.00 with out late fees . After 2-20-26 Late fees will apply.
